

LEGAL DESCRIPTION

BEING all of Lots 1, 2, 3, & 4, Block 21/548, and all of Lots 1 & 5 of Block 22/564, according to the Official Map of the City of Cleburne, Johnson County, Texas, and being more particularly described as follows:

BECINIING at the intersection of the North ROW line of West Wardville Street (a varying ROW) and the East ROW line of Shaw Street (a varying ROW) point also being the Southwest corner of Block 21/548, and being 10.00 feet from the center line of Shaw Street;

THRICE: N 30° 27° 20° W, 156.00 feet along the East ROW line of Shaw Street, being at all times parallel to and 10.00 feet from the center line of Shaw Street, to a point for

THENCE: N 61° 10° 09" E, 8.00 feet to a point for corner, said point being 18.00 feet from the center line of Shaw Street;

THENCE: N 30° 27° 20" W, 198.00 feet, being at all times parallel to and 18.00 feet from the center line of Shaw Street, along the East ROW line of Shaw Street to point for corner, said point being the Northwest corner of Lot 5 in Block 22/564 and the Southwest corner of Lot 4 of Block 22/564;

THE CE: N 61° 10° 09° E, 284.00 feet along the common lot lines of Lots 4 & 5, and Lots 1 & 2 in Block 22/564 to a point for corner in the West RCW line of Granbury Street (a varying RCW), being the Northeast corner of Lot 1 and the Scutheast corner of Lot 2 of

THENCE: S 30° 27° 20° E, 356.00 feet along the West ROW line of Granbury Street to a point for corner being the intersection of the West ROW line of Granbury Street and the North ROW line of West Wardville Street;

BECHNING at the intersection of the present Northwest ROW line of West Henderson Street (U.S. Highway 67) with the present Southwest ROW line of Granbury Street, a-cross in

THENCE: S 76° 26° W, 144.60 feet with the Northwest ROW line of North Henderson Street to a point for curve to the Left having a Radius of 1946.08 and a Central Angle of 3° 06°

THENCE: around said curve to the Left and with the Northwest ROW line of West Henderson Street a distance of 105.60 feet to an iron stake for corner being in the Northeast ROW line of Shew Street: THENCE: N 30° 26° 30° W, 258.00 feet with the Northeast ROW line of Shaw Street to an

iron stake for corner being in the Southeast ROW line of West Wardville Street; THENCE: N 63° 32' 40" E, 274.28 feet with the present Southeast ROW line of West Wardville Street to an iron stake for corner being in the present Southwest ROW line of Granbury

BEING a tract of land being all of a tract of land deeded to MORCAN GUARANTY TRUST COMPANY of New York, recorded in Volume 511, Page 675, Deed Records, being part of City Block 16/ 533, and all of Lots 1, 2, 3, and 4, Block 21/548, and all of Lots 1 and 5 of Block 22/564, and all of a street known as Wardville, lying between Blocks 16/533 and 21/548, according to the Official Map of the City of Cleburne, Johnson County, Texas and being nore particularly described as follows:

BECINNING at the intersection of the present Northwest ROW line of West Henderson Street (U.S. Highway 67) with the present Southrest ROW line of Granbury Street, a-cross in

THENCE: S 76° 26' V, 144.60 feet with the Northwest ROW line of North Henderson Street to a point for curve to the Left having a Redius of 1946.08 and a Central Angle of 3° 06'

THENCE: around said curve to the Left and with the Northwest ROW line of West Henderson Street a distance of 105.60 feet to an iron stake for corner being in the Northeast ROW line of Shaw Street:

THENCE: N 30° 26' 30" V, 258.00 feet with the Northeast ROW line of Shaw Street to an iron stake for corner being in the Southeast ROW line of West Wardville Street THENCE: N 40° 40. 04° W, 39.44 feet crossing Wardville Street to a point for corner; THENCE: N 30° 27° 20° W, 156.00 feet along the East EOW line of Shaw Street to a point for

THENCE: N 61° 10° 09" E, 8.00 feet to a point for corner, said point being 18.00 feet from the center line of Shaw Street;

THENCE: N 30° 27' 20" W, 198.00 feet, being at all times parallel to and 18.00 feet from the center line of Shaw Street, along the East ROW line of Shaw Street to a point for corner, said point being the Northwest corner of Lot 5 in Block 22/564 and the Southwest corner of Lot 4 of Block 22/564;

THENCE: N 61° 10° 09° E, 284.00 feet along the common lot lines of Lots 4 & 5, and Lots 1 & 2 in Block 22/564 to a point for corner in the West ROW line of Granbury Street (a varying ROW), being the Northeast corner of Lot 1 and the Southeast corner of Lot 2 of Block 22/564:

THENCE: S 30° 27° 20° E. 356.00 feet along the West ROW line of Granbury Street to a point for corner being the intersection of the West ROW line of Granbury Street and the North ROW line of West Wardville Street; THENCE: S 17° 08' 43" E, 48.98 feet crossing Wardville Street to a point for corner;

THENCE: S 24° 16° E, 310.60 feet with the present Southwest ROW line of Grenbury Street to the PIACE OF BECINNING and containing 187,585.25 square feet or 4.3064 acres of land.
